

Where to File a Sexual Harassment Complaint

Title IX is a Federal civil rights law that prohibits discrimination on the basis of sex in education programs and activities. Sex discrimination is also prohibited by University policy. Discrimination on the basis of sex includes sexual harassment and sexual violence. If you believe that you have been a victim of discrimination on the basis of sex or are aware of discrimination occurring, the University encourages you to report the incident.

- ❖ Ross Matthews, Director of Human Resources, is the point of contact if the respondent is a staff employee.
- ❖ Roger White, Special Assistant to the Provost, is the point of contact if the respondent is a member of the faculty.
- ❖ Jayme Naquin, Director of Risk Management, is the point of contact if the respondent is a non-Loyola community member (sub-contractor, vendor, etc.)

Any complaint may also be made to the Title IX Coordinator or one of the Title IX Deputy Coordinators
